#### **INTRODUCTION**

#### SALE OF SURPLUSED ELECTRICAL WIRE

It is the intent of the City of Alexandria to offer for sale to the <u>highest proposer</u>, surplused electrical wire, owned by the City of Alexandria Electric Distribution Department. This surplused electrical wire was taken down during several reconductoring projects throughout the City of Alexandria.

This wire is being sold "AS IS", "WHERE IS", with NO warranties by the City of Alexandria either written of implied. It shall be the responsibility of the awarded proposer to furnish all equipment, labor and personnel necessary to remove ALL surplus wire from its present location at the City of Alexandria Central Warehouse, located at 2021 Industrial Park Road, Building WH, Alexandria, LA 71303.

Successful proposer shall be responsible for removing the surplused wire from the Central Warehouse location by December 19, 2014.

#### **Insurance Requirements:**

Each proposer shall furnish, attached to their proposal, a current copy of his Certificate of Insurance indicating limits of General Liability, Automobile Liability and Worker's Compensation in force at the time of the bidding. Evidence of reliable insurance to fully indemnify against long-term liabilities shall be part of the evaluation criteria for award of this bid. Certificate of Insurance shall have a General Liability Aggregate of Four Million (\$4,000,000) Dollars and a per person/per occurrence of Two Million (\$2,000,000) Dollars. Automobile Liability will have a Combined Single Limit of Two Million (2,000,000). Also on the Certificate, the City shall be named as an "additional insured" and a waiver of subrogation in favor of the City of Alexandria. On the Certificate of Insurance under Worker's Compensation, it shall state that "This is a standard Worker's Compensation Policy", with statutory limits. Cancellation of any Certificate of Insurance should require sixty (60) days notice to the City of Alexandria, but under no circumstances less than thirty (30) days notice. Also, the following wording must be removed before acceptance of the Certificate: "Endeavor to" or "But failure to mail such notice shall impose no obligation of liability of any kind upon the company, its agents or representatives." Certificate holder shall be the City of Alexandria, P.O. Box 71, Alexandria, LA 71309-0071, Attention: Purchasing Manager.

The successful proposer will be required to provide a <u>Cashier's Check for the total amount of the purchase</u> PRIOR to the pickup of all surplus wire. The City of Alexandria will only accept proposals from companies that are established and in the day-to-day business of purchasing scrap metal, wire, etc.

Attached is a listing of the surplus wire for sale, wire size, and approximate weight as well as photos of the same.
