This is the City Council Committee Meetings schedule for Tuesday, April 19, 2022 that will be held in the City Council Chambers. The meetings shall begin at 3:00 p.m. unless otherwise designated.

**Finance and Legal Affairs Committee at 3:00 P.M.**

- 1) To consider final adoption of an ordinance adopting the Operating Budget for the City of Alexandria for fiscal year 2022/2023; to make appropriations for the ordinary expenses of all city divisions, departments, offices and agencies, pensions and otherwise providing with respect to the expenditures of appropriations; adopting the Capital Budget for the City of Alexandria for fiscal year 2022/2023; appropriating funds for the Capital Budget for the city of Alexandria for fiscal year 2022/2023 and providing for capital expenditures; and other matters with respect to appropriations and the expenditure of funds pertaining thereto.

- 2) To consider final adoption of an ordinance authorizing the Mayor to renew the existing contract with Bonnette Auction Company for professional auctioneering services.
- 3) To consider final adoption of an ordinance authorizing the Mayor to renew the contract with the State of LA-Veterans Affairs.
- 4) To consider final adoption of an ordinance authorizing the Mayor to enter into a contract with Caring Choices of Alexandria for services related to substance abuse treatment, education and deterrence.
