- Page 2 (Scope of Work): DELETE item #4 entirely since air monitoring is not required by EPA:
   <u>AIR MONITORING</u>: clearance air monitoring shall be performed and clearance sampling provided. A minimum of 4 Phase Contrast Microscopy (PCM) ambient air samples shall be collected at the perimeter of the work area.
   <u>All air monitoring shall be performed by a Louisiana accredited contractor/supervisor and analyzed using PCM in accordance with the National Institute for Occupational Safety and Health's (NIOSH) 7400 Analytical Method by persons with NIOSH 582 equivalent training and proficient per an American Industrial Hygiene Association (AIHA) Proficiency Analytical Testing (PAT) Program.
  </u>
- 2. Page 13 (Contractor Fee Schedule): REPLACE entire page with attached.
  - a. Item #2 related to air monitoring has been deleted. Subsequent items have been renumbered.
  - b. New Item #3 remove "& Debris" at the end of the item description.
  - c. Estimated Quantities have been added to each line item to provide an extended price.
