

- 2) To consider final adoption of an ordinance adopting the Operating Budget for the City of Alexandria for fiscal year 2020/2021; to make appropriations for the ordinary expenses of all City Divisions, Departments, Offices and Agencies, Pensions and otherwise providing with respect to the expenditures of appropriations; adopting the Capital Budget for the City of Alexandria for fiscal year 2020/2021; appropriating funds for the Capital Budget for the City of Alexandria for fiscal year 2020/2021 and providing for capital expenditures; and other matters with respect to appropriations and the expenditure of funds pertaining thereto.
