REQUIREMENTS AND REGULATIONS

- Participants must provide "AlexWinterFête" a certificate of insurance evidencing a minimum one (1) million combined single limit general liability coverage listing the City of Alexandria, Alexandria Festival Association and Arts Council of Central Louisiana as additional insureds.
- If required in their normal business operations, vendors shall carry and provide proof of Workers' Compensation coverage in the amount standard with those required by the State of Louisiana.
- Vendors will not be allowed to sell or give away alcoholic beverages without obtaining additional authorization from the City; contact the Division of Community Services if this applies.
- Vendor exhibit (including signage) should not extend beyond booth space or block other booths or walk ways.
- All participating vendors must display professional looking booths.
- Participating vendors are expected to comply with all rules and regulations of the Alexandria Police Department, Alexandria Fire Department, Rapides Parish/State of Louisiana Health Department and any other governing authorities' rules and regulations that might apply.

Vendor fees are \$150 for a 10 X 10 vending space (\$300 for 10x20 etc.), including a tent and access to electrical hook-up and a central trash depository.
