PROCEEDINGS OF THE COUNCIL OF THE CITY OF ALEXANDRIA, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD ON AUGUST 7, 2018.

The Council of the City of Alexandria, Louisiana, met in a regularly scheduled meeting session at its regular meeting place, on Tuesday, August 7, 2018 at 5:00 P.M. Those present were the Honorable Roosevelt Johnson, Jim Villard, Joe Fuller, Jules Green, Ed Larvadain, Chuck Fowler and Harry Silver. Also present were Mayor Roy, Council Staff and Council Attorney Trey Gist.

The Council of the City of Alexandria, State of Louisiana, was duly convened as the governing authority of said City by the Honorable Roosevelt Johnson, who stated that the Council was ready for the transaction of business. The Invocation was pronounced by Mr. Silver and the Pledge of Allegiance was led by Mr. Larvadain.

Mr. Johnson welcomed each Councilman who attended the LMA Conference, to speak on what they learned at the meetings. Mr. Green spoke about a class on blighted properties, Mr. Fuller spoke on capital outlay money, Mr. Larvadain spoke on small cell technologies and public records requests, Mr. Villard mentioned how impressed he was at how much further Alexandria is advanced compared to smaller communities and Mr. Johnson said he enjoyed learning about community policing.
