

PROCEEDINGS OF THE COUNCIL OF THE CITY OF ALEXANDRIA, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD ON DECEMBER 11, 2018.

The Council of the City of Alexandria, Louisiana, met in a regularly scheduled meeting session at its regular meeting place, on Tuesday, December 11, 2018 at 5:00 P.M. Those present were the Honorable Jim Villard, Gerber Porter, Joe Fuller, Jules Green, Ed Larvadain, Chuck Fowler and Harry Silver. Also present were Mayor Hall, Council Staff and Council Attorney Trey Gist.

The Council of the City of Alexandria, State of Louisiana, was duly convened as the governing authority of said City by the Honorable Jim Villard, who stated that the Council was ready for the transaction of business. The Invocation was pronounced by Mr. Green and the Pledge of Allegiance was led by Mr. Fowler.

APPROVAL OF MINUTES

On a motion of Mr. Green and seconded by Mr. Fowler the minutes taken from a regular meeting held November 27, 2018 Council Meeting were unanimously approved by the Council.

Mr. Fowler corrected comments made at the previous Council Meeting pertaining to the Dog Park. The idea of the Dog Park came from public request and the taxpayers voted for the project. He also clarified that money removed from one line item and placed into another line item were not taken from a project, but were moved to balance out funds.

Mr. Fuller motioned to move agenda items 21 and 22 to the top of the agenda.
