

PROCEEDINGS OF THE COUNCIL OF THE CITY OF ALEXANDRIA, STATE OF LOUISIANA, TAKEN AT A SPECIAL MEETING HELD ON MARCH 18, 2019.

The Council of the City of Alexandria, Louisiana, met in a special scheduled meeting session at its regular meeting place, on Monday, March 18, 2019 at 2:00 P.M. Those present were the Honorable Jules Green, Jim Villard, Chuck Fowler, Gerber Porter and Joe Fuller. Harry Silver was absent. Also present were Mayor Hall and Council Staff.

The Council of the City of Alexandria, State of Louisiana, was duly convened as the governing authority of said City by the Honorable Jules Green, who stated that the Council was ready for the transaction of business.

Mr. Green announced that the City Clerk had received notice of the vacancy in District One from the Louisiana Secretary of State's Office and that such notice be made part of the record.

RESOLUTIONS

Mr. Fuller moved for the adoption of the following resolution, which was seconded by Mr. Villard.

RESOLUTION NO. 9899-2019

RESOLUTION APPOINTING RONALD DEJOIE TO FILL A VACANCY IN THE OFFICE OF THE CITY COUNCIL DISTRICT ONE FOR THE CITY OF ALEXANDRIA CITY COUNCIL AND OTHERWISE TO PROVIDE WITH RESPECT THERETO.

RESOLUTION RECOGNIZING A VACANCY IN THE UNEXPIRED TERM OF OFFICE FOR THE CITY COUNCIL DISTRICT ONE AND ISSUING A PROCLAMATION ORDERING A SPECIAL ELECTION TO FILL THE VACANCY IN ACCORDANCE WITH THE ALEXANDRIA HOME RULE CHARTER AND THE ELECTION LAWS OF THE STATE OF LOUISIANA AND PROVIDING THAT THE ELECTION DATES SHALL BE CONSISTENT WITH THE STATE ELECTION DATES FOR THE GUBERNATORIAL PRIMARY AND GENERAL ELECTION AND OTHERWISE PROVIDING WITH RESPECT THERETO.

The President called for any discussion, a vote was called for and resulted as follows:
