The Council of the City of Alexandria, Louisiana, met in a regularly scheduled meeting session at its regular meeting place, on Tuesday, November 26, 2019 at 5:00 P.M. Economic Workforce and Planning Development Committee Chair, Mr. Fuller said the committee had previously received a report on Main Street Programming and the Jake's building. He asked the Mayor to get started on the ACEDD Board.

Community Affairs, Services and Events Committee Chair, Mr. Larvadain reminded everyone that the City offices were closed Thursday and Friday for the Thanksgiving Holiday.

Mr. Fowler congratulated the Finance Division and the Administration for having a clean audit. He stated that they had done a fantastic job.

Mr. Green reminded the Administration that the next Council meeting is on December 10 and that all fact sheets would be due by December 3 at Noon. Then he wished everyone a Happy Thanksgiving.
