E. Acknowledgement by Person Performing the Demolition Work By signing this document, I agree to:

1. Permit processing is a **minimum of five (5) business days** after this application is received by the Permit Office for utilities to be disconnected and a Demolition Permit to be issued. **If taps are to be removed, it will take a minimum of ten (10) business days.** Contractor must call LA One Call 48 hours prior to any digging.
2. **All CmDv Demolition permits issued must demolish the structure(s) within thirty (30) calendar days of permit issuance.** This is because the City is in receipt of complaints against the structure that require attention immediately to protect the health, safety and welfare of the surrounding area.
3. Conform to the International Codes and City adopted Ordinances by removing all debris, including concrete steps or driveways, and accumulation of materials resulting from the demolition of the premises and by filling all surface holes, irregularities, septic tanks, etc., so that the property is graded in such a manner and in a rake-clean condition that will provide effective surface drainage and drain toward the street.
4. If hazardous materials are present, such as asbestos, proper abatement is required per DEQ regulations, if the structure is being demolished with HUD/COA funds.
5. Contact Sanitation Department at 318-441-6078 for debris removal and cost if the debris is not being hauled to a certified dump site.
6. **If the structure has been condemned by City Council, the CmDv Inspector shall identify the structure in ORANGE PAINT with physical address in big letters.**
7. State Licensing Requirements shall be in compliance. Residential demolition contract value over \$7,500 shall possess a Demolition Contractors License. Commercial demolition contract value over \$50,000 shall possess a Demolition Contractors License. ***If the Contract Value is shown as \$0.00 and the work is being performed in trade for the salvage or reclaiming of materials, State Licensing Requirements shall still apply if the value of the salvaged materials falls into the monetary amounts listed in this section. 8. All persons wishing to perform demolition work within the City of Alexandria shall first have a Jurisdiction Registration with the City before a Permit can be issued.
9. I have read and examined this application in its entirety and have completed the appropriate sections of this application and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. The granting of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulation construction or the performance of construction. The proposed work is authorized by the owner of record and that I am or have been authorized by the owner to make this application as the authorized agent and agree to conform to all applicable laws of this jurisdiction.
